

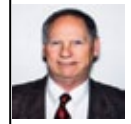
**HOW MCGRANN SHEA CARNIVAL STRAUGHN & LAMB BEGAN**

Bill McGrann, Andy Shea, Doug Carnival, Doug Franzen, Kathleen Lamb resigned from O'Connor & Hannan on the morning of Thursday December 14, 1989 due to O'Connor & Hannan's representation of the government of El Salvador headed by President Alfredo Cristiani.

On the afternoon of December 14, 1989, the firm opened its doors, sharing office space with a leasing agent at the Lincoln Centre (now Accenture Tower). Bonnie Voegelé and Sue Powers came over as secretaries and Norma Schumacher came over as a legislative assistant. Bonnie Voegelé remains with the firm to this day as a special assistant. On that day, phone calls were made and clients were thankfully retained. On December 15, 1989 the firm finished its first full day, celebrating with champagne, thus starting the firm tradition of Friday treats, now the monthly employee recognition lunch.

The firm started as McGrann Shea Franzen Carnival & Lamb, Chartered, with its main goal, at least at first, being that of survival, one day at a time. Office furniture consisted of folding tables and chairs along with a few milk crates. The firm's first conference table and chairs were free, left behind by a tenant who failed to pay their rent at the Lincoln Centre. That conference table remains to this day, currently located in Conference Room Three.

Clients that stayed with the firm at its inception included the Minnesota Teamsters Construction Division Fringe Benefit Funds, Minneapolis BOMA, Minnesota Municipal Utilities Association (MMUA), Southern Minnesota Municipal Power Agency (SMMPA), Minneapolis Community Development Agency (MCDA), Grand Metropolitan PLC in their acquisition of Pillsbury, Rochester Public Utilities (RPU), Minnesota Laborers, Shakopee Public Utilities and numerous other public utilities.

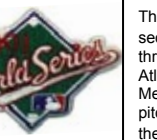
**Back in business/Dissenting lawyers regroup**

A group of about seven lawyers who had resigned from the O'Connor & Hannan law firm in Chicago on Wednesday announced that they had regrouped in Minneapolis to form a new law firm. The new firm, McGrann Shea Franzen Carnival Straughn & Lamb, Chartered, is located at the Lincoln Center building in downtown Minneapolis. The firm's first conference table and chairs were left behind by a tenant who failed to pay their rent at the Lincoln Center. That conference table remains to this day, currently located in Conference Room Three.



**June 1, 1990**  
**Hilton Convention Center Hotel.** A month-long closing conducted in Chicago for the development phase and financing of the Hilton Convention Center Hotel is successfully concluded. The firm completed significant legal work on this 800-room downtown hotel and underground parking ramp as counsel to the Minneapolis Community Development Agency. The facility opened in November 1992.



**December 14, 1990**  
McGrann Shea Franzen Carnival Straughn & Lamb celebrates its first anniversary.



**October, 1991**  
The Minnesota Twins win their second World Series with a thrilling Game 7 win over the Atlanta Braves at the Metrodome. Jack Morris pitched 10 shutout innings in the 1-0 Twins win.



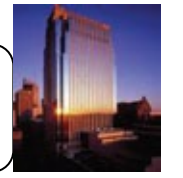
**The Minneapolis Convention Center** opens following the firm's securing of \$87 million in state bond funding. The firm completed significant legal work on the project.



**January 1992**  
The Metrodome hosts Super Bowl XXVI. In the span of October 1991 - March 1992, the Metrodome hosts the World Series, the Super Bowl and the NCAA Men's Basketball Final Four. In fact, the Metrodome is the only facility to host a Major League Baseball All Star Game (1985), World Series (1987, 1991), Super Bowl (1992) and NCAA Final Four (1992, 2001). In addition to the above noted events, in May and June of 1991, the Twin Cities also hosted the Stanley Cup Finals at the Met Center and the U.S. Open at Hazlettine National Golf Club. In 1991-1992 the Twin Cities was the center of the sporting universe.



**April 15, 1993**  
McGrann Shea moves to suite 2200 in the LaSalle Plaza building.



**August, 1993**  
The firm acts as bond counsel for the \$4,250,000 Shakopee Public Utilities Revenue Bonds.

**December 14, 1994**  
McGrann Shea celebrated its fifth anniversary. In its first five years, McGrann Shea had moved well beyond its initial goal of survival. The coming years would display the firm's talents and influence as it would play a key role in many significant legislative matters and building projects that would come to define the Twin Cities in general and the City of Minneapolis in particular.

**January 2, 1990**  
McGrann Shea, seeking to develop its real estate and litigation practices, added Bob Straughn, Peter Cooper and Rick Evans from O'Connor & Hannan as shareholders. The firm changed its name to McGrann Shea Franzen Carnival Straughn & Lamb, Chartered. Major clients that followed the new shareholders included Frauenshuh Companies and its development partner U S West Real Estate.

**June 13, 1990**  
McGrann Shea adds the Metropolitan Sports Facilities Commission as a client. The Commission managed, among other things, the Metrodome and Met Center. In the late 1970's, Bill McGrann played a key lobbying role in the passing of the legislation that provided the funding and the authorization for the building of the Hubert H. Humphrey Metrodome.



**January 8, 1990**  
Karen Weber joined the firm as secretary and, along with Bonnie Voegelé, remains with the firm today. The firm moves into its own space on the 17th floor at Lincoln Center.



**September 1990**  
The firm acts as bond counsel for its first tax-exempt bond issue, the \$6,550,000 Owatonna Public Utilities Revenue Bonds.

**October 1990**  
Minnesota Financial Development Corporation (MFDC) and its investors close on the acquisition and bond refunding of the Highland Hills of Mankato apartment project. The firm completed significant legal work on behalf of MFDC on this and two subsequent apartment project acquisitions in Mankato. MFDC and partners through its Highland Hills entities currently own and operate over 800 rental apartments in Mankato.

**October 1, 1990**  
The firm, in need of an additional litigator, hired Corey Ayling from O'Connor & Hannan.



**June 1991**  
The eighth phase of Laurel Village opens in downtown Minneapolis. The firm completed significant legal work related to this 1,000 unit multi-block apartment complex on Hennepin Avenue on behalf of the Minneapolis Community Development Agency.



**LaSalle Plaza** opens in downtown Minneapolis. The firm completed significant legal work on this 1,000,000 square foot project, which includes the LaSalle Plaza office building, the new downtown YMCA, and renovation of the State Theater. The project was developed by firm clients Frauenshuh and U S West Real Estate. In 1993 the firm moved to the LaSalle Plaza.

**November 1992**  
Bill Clinton elected the 42nd President of the United States.



**Dinnaken Properties.** The firm worked on rezoning and obtaining approvals for student housing to be built adjacent to the University of Minnesota campus. The residential units represented the first privately-owned residential dormitory at the University of Minnesota campus.

**September, 1993**  
The firm acts as underwriter's counsel to Morgan Stanley & Co. for a \$103 million bond financing on behalf of Southern Minnesota Municipal Power Agency. In November, 1995 the firm represented Morgan Stanley as underwriter's counsel for a bond financing on behalf of Western Minnesota Municipal Power Agency (the financing affiliate of Missouri River Energy Services). The firm has served as underwriter's counsel for Morgan Stanley, Goldman Sachs, Citi, RBC Capital Markets, Piper Jaffray and Dougherty in bond issues for Southern Minnesota Municipal Power Agency, Western Minnesota Municipal Power Agency and Laurentian Energy Authority LLC aggregating over \$1.5 billion.

**May 31, 1994**  
Kathleen Michaela (Kaela) Brennan is hired as a law clerk.



**Washington County Housing and Redevelopment Authority.** The firm is engaged as general counsel by the Washington County HRA. The firm provides general counsel, litigation development representation to the HRA. In addition, as the HRA has its own substantial portfolio of affordable and senior housing apartments, McGrann Shea handles all aspects of landlord-tenant, regulatory and related matters on behalf of the HRA with respect to such housing.

**August 1996**

The Olympic Summer Games are held in Atlanta, Georgia.



**Midway Marketplace.** The Midway Marketplace shopping center opens at the site of the former Montgomery Ward department store and catalog warehouse on University Avenue in Saint Paul. The firm represented Montgomery Ward in this 500,000 square foot urban retail project.

Jesse Ventura "Shocked The World" and is elected Governor of the State of Minnesota.

**Park Village.** The firm assisted its client, Frauenshuh, in development of a 250,000 square foot mixed use project in Saint Louis Park. **September, 2001**

Groundbreaking ceremonies for Loring Park City Apartments, the first development project in the city of Minneapolis undertaken by Jonathan Holtzman's Village Green Companies. The firm completed significant legal work on behalf of Village Green on this 160-unit apartment project and four other Village Green apartment development projects in Minneapolis, including Uptown City Apartments, Lake Calhoun City Apartments, Eitel Building City Apartments and most recently, Mill District City Apartments, comprising of approximately 800 units with total development costs in excess of \$150 million.



**September 11, 2001**

Terrorist attacks occur at the World Trade Center, the Pentagon, and Pennsylvania.

**River Parkway Plaza** (Padilla Speer Building)

The firm assisted Ryan Companies in the redevelopment of an abandoned railyard. This became one of the first new buildings constructed near the Mississippi River, leading the way for the redevelopment of the entire area.



**April 2002**

**Guthrie Theater**

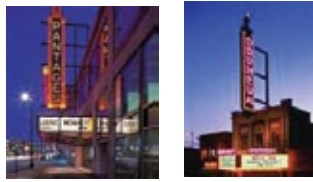

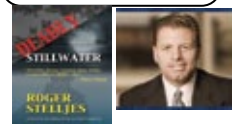
